

**The Illinois Department on Aging
Announces Agencies Participating in the Adult Component of the
Child and Adult Care Food Program**

SPRINGFIELD - The Illinois Department on Aging announces the availability of the Adult Component of the Child and Adult Care Food Program (CACFP). Listed below are Adult Day Service agencies approved to participate in the USDA's CACFP for the current Federal Fiscal Year 2020 beginning October 1, 2019 through September 30, 2020.

The CACFP program, administered by the U.S. Department of Agriculture and the Illinois Department on Aging, gives financial assistance to the state-contracted Adult Day Service program for meals and/or supplements served during the provision of Adult Day Service. The meals and supplements (also known as 'snacks') served to enrolled participants meet standards established by the U.S. Department of Agriculture.

Listed below are the USDA Income Eligibility Guidelines which are effective July 1, 2019 through June 30, 2020. The amount of reimbursement received by the agency is based on the number of enrolled participants whose family income is at or below:
