#### SUMMARY

#### Welcome and Introductions

Director Johnson welcomed all members and introduced the new members to the committee.

#### Approve November 15, 2010 OASAC Minutes

Myrtle Klauer moved and Tom Prohaska seconded that the minutes be approved. The minutes were unanimously approved.

#### **Michael Gelder, Governors Office Report**

Mr. Gelder reported about the concern with the backlog in unpaid bills. The revenue generated with the new tax is not to increase spending but to get our house in order. The General Assembly proposed limits on what the states can spend. Even with the tax increase passed, the tax increase is null and void if the state overspends by even one dollar. Pension commitments continue to increase with the aging of the workforce. The Governor's priorities include: jobs/growing economy, education, public safety, human services to serve the most vulnerable.

The Human Service budget had minimal cuts to CCP which is Medicaid matchable based on serving only new Medicaid-eligible participants beginning July 1, 2011. In the State's LTC budgeting, line items were identified throughout the budget that can be looked at comprehensively or a single line item for LTC. Resources are needed for both institutional care and home and community-based care. Waiver programs need to be reconsidered in such a way so that persons are not prevented from leaving the nursing home and returning to the community.

### **Ethics Training Certification Forms**

#### **Executive Committee Report – Susan Real**

Susan Real was ill so IDoA staff gave a brief summary of the last meeting and noted that minutes are posted on the IDoA website.

#### **Presentation on Illinois Transitions Care Consortium**

Guest Speaker: Walter Rosenberg, Rush Medical Center

The Bridge Program was presented which is a model to improve care transitions from hospital discharge to home using masters prepared social workers as care coordinators. The Illinois model is operating in urban, rural and suburban locations in the State.

#### **Program Logic Model on Top 5 Priority Areas**

IDoA staff shared program logic model diagrams for each of the top 5 priority areas which the state agencies will be addressing in the coming year.

#### **New Work Groups**

The Executive Committee recommended the formation of 2 workgroups for 2011.

- 1. Housing/Access to Community Settings (Lead: Sam Mordka/IHDA)
- 2. Access to Community Supports (Co-Leads: Carol Aronson and Susan Real)

Committee members were encouraged to volunteer and sign-up sheets were circulated. The Housing workgroup will focus on 1) Outreach to the aging network regarding aging units that were set aside but still vacant, and 2) the ILHousingSearch.org locator to allow for private access for caseworkers and transition coordinators for subsidized housing opportunities. Department staff will work with the co-leads on the Access to Community Supports workgroup to define priorities.

#### **State Department Progress on Priority Areas**

#### **Illinois Department on Aging**

- Director Johnson provided an update on the IDoA Budget. CCP may become a Medicaid-only program, and the Circuit Breaker/IL Cares Rx program is proposed to be eliminated. Stephanie Altman reported that there is a coalition trying to save ILCaresRx and CB (600+ groups), led by AARP. 200,000 people are on just the medication portion of the program, and the implementation of the Affordable Care Act does not cover the entire donut hole created in Medicare Part D until 2019.
- Lisa Zuurbier informed the group about ADRC Options Counseling

- Lance Kovacs gave a legislative update. Rep. Hernandez is the new Chair of House Aging Committee. Representative Hernandez is carrying 3 IDoA initiatives HB 2019, HB 2020 and HB2043. Lance also reported on other legislation of interest to OASAC.
- SB1353 (Schoenberg) proposed moving the LTC Ombudsman Program to Attorney General's office. Fed law requires that Ombudsman be housed in State Agency on Aging.
- HB1328 (Rep Dugan) proposes a 90 day notice to alter or terminate a vendor.
- HB1426 (Rep Bradley) proposes amendments to the enabling OASA legislation, including the requirement to develop a report for the General Assembly on the inventory of services and priority service areas by January 1, 2012. A motion was made by Dave Vinkler and seconded by Phyllis Mitzen. Motion: OASAC members intending to submit a bill related to the OASAC enabling legislation will inform the OASAC committee prior to going to the legislative committee. Discussion: OASAC doesn't have the authority to bind a piece of legislation being introduced, and given that OASAC only meets quarterly it could be difficult to comply with the motion. The motion passed.
