# Review of Action of Older Adult Services Advisory Committee on Short-Term Recommendations:

A review was conducted of the changes made to the short-term recommendations by the Older Adults Services Advisory Committee. IDOA document from Leann used for this purpose.

# Requested consideration on Overarching Recommendations and Long-Term Recommendations:

The overarching recommendations are considered a preamble for the entire report.

Recommendations not to be seen as limited to home and community based services but should reflect the continuum of services available.

# Recommendations not acted upon by Older Adult Services Advisory Committee:

**EHRS:** move under CCP.

**#7:** Illinois Department of Health Care and Family Services shall develop a mechanism for soliciting local seniors planning input form the community on the location of SLF. Group voted to remove statement because HCFS already has a process in place for such input.

Group agreed that long-term recommendations should not be viewed as all inclusive and will be the focus of the committees work and will serve to focus the committee work for the future. Additional recommendations will be made by the group based on policy and budgetary developments.

**Long-Term Housing:** Members agreed to the "Establish regionally placed specialized supportive living facilities for adults with serious and persistent mental illnesses" as recommended language.

**Ombudsman Program:** Eliminated reference to \$750,000. Members support no cuts to the funding in FY08.

**Housing and Services**: A change in wording requested – "Begin to investigate the consolidation." Members approved.

**EHRS:** move it to the short-term. Members approved.
