Dear Aging Network:

February is [Black History Month](#), which is a time to celebrate the achievements of African Americans and honor the significant role and impact they have made on all facets of life and society throughout U.S. and Illinois history. We also must acknowledge the health inequalities in our society and recognize our need to do better at seeing and respecting our shared humanity - dismantling a system that privileges some over others. Governor Pritzker's mission has always been to promote and instill a culture of equity and respect for all people, and the Aging Network must do its part to address the disparate impact of COVID-19 on African Americans and other communities of color.

To help assist in these efforts, I am proud to report that our Area Agencies on Aging (AAAs) are receiving a \$1.2 million grant to provide direct assistance and support to older adults with the vaccination registration process. This grant will enable the AAAs to increase their outreach and education on the vaccine to our most vulnerable older adults, including our minority populations. Additionally, our Care Coordination Units (CCUs) continue to directly outreach to Community Care Program participants and determine their need for assistance with the vaccination registration process. Emergency Senior Service funding is available to all our CCUs for the provision of assistance, which includes transportation needs. Please contact your IDoA program coordinator for more information. Furthermore, we continue to update [IDoA's COVID-19 Vaccine webpage](#), and we encourage you to check out the information, videos, and helpful links meant to dispel myths and rumors about the vaccine and promote vaccine distribution.


