## Dear Aging Network:

It was great seeing so many of you on Senior Day at the Illinois State Fair. If you weren't able to join us, you can watch the kick-off recording, including the launch of our new "Long Live Illinois" campaign, <a href="here">here</a>. The "Long Live Illinois" campaign aims to ensure Illinois seniors are up to date on their COVID-19 vaccinations.

Joined by the Department of Public Health and Department of Healthcare and Family Services, the state's top three health-focused agencies celebrated the campaign launch alongside Governor JB Pritzker and Lt. Governor Juliana Stratton.

Governor Pritzker spoke directly to older Illinoisans on the fairgrounds, telling a room full of seniors: "Thank you also for your dedication, seniors, for keeping up to date on your COVID boosters. You've heard a lot of promotion of it from the folks behind me that so many have already done the right thing for themselves and their families and that really is a wonderful thing."

Vaccination remains the best tool to protect Illinoisans from COVID-19, and it's especially important for older residents to get fully vaccinated since they are more likely to get seriously ill from the virus. The "Long Live Illinois" campaign will reach unvaccinated and under-vaccinated older adults to ensure they know about the benefits of the COVID-19 vaccine and where to get vaccinated.

The campaign will employ paid media, including radio and targeted digital media, and community partnerships with local organizations, religious leaders, and healthcare providers to reach these residents and keep them informed about the benefits of the COVID-19 vaccine and state resources. As part of the Senior Day festivities, Governor Pritzker also announced the launch of the Program of All-Inclusive Care for the Elderly (PACE). The PACE program expands options for community-based care and serves as an alternative to traditional nursing facility care, allowing eligible older adults to continue living safely at home.
