## **AGENDA ITEMS**

#### Call to Order

CCPAC Co-Chair, Theresa Collins officially called the meeting to order at 10:03 A.M.

## Welcome and Introductions

Welcome remarks from CPPAC Co-Chair, Theresa Collins.

#### **CCPAC Member Roll Call**

CCPAC Co-Chair, Theresa Collins completed a full member roll call.

#### June 12, 2023, CCPAC Meeting Minutes – Theresa Collins, CCPAC Co-Chair

Shana Holmes presented a motion to approve the June 12<sup>th</sup> meeting minutes, LaShun James seconded the motion. It was carried with no comments or objections.

#### Public Comments – Theresa Collins, CCPAC Co-Chair

The invitation for public comments was opened. No public comments were made.

#### New CCPAC Subcommittees - Mary Killough, IDoA Director

Legislative/Policy subcommittee – To review and provide feedback on new legislation and policies being introduced.

Audit/Monitoring subcommittee – Look at the deficiencies that are common in monitoring and discuss current concerns with the current monitoring process and challenges being seen on both sides. Review the monitoring tool and determine is any changes are needed.

Bylaws subcommittee – Being set up to review and determine if changes are needed in the CCPAC Bylaws.

#### Budget Update – Liz Vogt, IDoA Senior Policy Advisor

Slideshow presented on FY25 Enacted Budget for IDoA (Public Act 103-0589).

A copy of the slideshow was shared with the post meeting materials.

Total enacted budget of \$1.86B, an 11.6% increase from the FY24 final budget.

- Overall, the enacted budget maintains programs for Illinois seniors with notable increases:
  - Home Delivered Meals increase of \$3 million from FY24 final budget
    - Offsets increased costs of food and delivery
  - •CCP increase of \$182.7 million from FY24 final budget
    - •FY24 supplemental received -\$48 million
    - •FY25 additional funding -\$134.7 million
      - •Includes 1/1/25 rate increase of \$1.56 to \$29.63 –cost of \$34.3 million
      - •Includes 1/1/24 rate annualization
      - Utilization and caseload increases
      - Annualization for EHRS service enhancements (GPS and fall detection)

## <u>Proposed Rate Increase – Liz Vogt, IDoA Senior Policy Advisor; Mike Berkes, Planning, Research, Development & Training</u> Division Manger

Rate increase coming January 2025:

In-Home Service Provider Rate increase consists of a 5.6% increase - \$28.01 to \$29.63, increase of \$1.56.

Requires a waiver amendment which is being worked on with HFS to be submitted to Federal CMS.

## Audits - Mary Killough, IDoA Director

Reminder that all provider agencies must supply their financial audit annually. Any agency that has not yet submitted their annual audit has been notified and should complete and submit that as soon as possible.

## Training Subcommittee Survey - Liz Vogt, IDoA Senior Policy Advisor

Training Survey was offered in 10 different languages. Survey was kept open past June 21st.

Response data as of June 21st:

3,512 in English 30 in Polish

307 in Chinese 7 in Tagalog

160 in Spanish 7 in Arabic

78 in Gujarati 2 in Hindi

51 in Russian 0 in Assyrian

More information to come on the survey results once the data has been reviewed.

## <u>Direct Care Workforce IDoA Peer Learning Collaborative – Liz Vogt, IDoA Senior Policy Advisor; Jennifer Hebel, IDoA</u> Special Research Assistant

Illinois applied for a technical assistance opportunity through the Administration for Community Living's Direct Care Workforce Strategies Center. The Federal government is convening a large group of technical experts and Federal agency representatives to create an opportunity for States to apply for different technical assistance grants. Illinois was selected to participant in a peer learning collaborative technical assistance opportunity to kick off in June. Illinois is paired with California, Kansas, and Connecticut. Focus will be on training, certification, and career ladders.

## Policy Updates - Liz Vogt, IDoA Senior Policy Advisor

## **Choices for Care:**

When an individual is being discharged from an acute care setting, a care coordinator (choices screener) from the CCU visits that individual at the hospital and conducts an assessment (DON), then discusses the services and programs that are available to them.

As a partner in this space with HFS, IDoA is updating the Choices for Care policy to align with the current practice as HFS considering the PASRR redesign. This should provide CCUs with the tools needed to help older adults transition out of nursing facilities.

## LRI:

During the pandemic, CMS allowed states to implement a flexibility to allow Legally Responsible Individuals to be paid home care aides. Policy is being updated to include LRI on a permanent basis.

New Billing Code 025 is being added for use with LRI.

## <u>IATP – Illinois Care Connections – Jennifer Hebel, IDoA Special Research Assistant</u>

1,764 referrals in FY24, up from 560 referrals in FY23.

90% of participants received a tablet, 40% received a piece of assistive technology or durable medical equipment.

## Starting June1:

- New ICC referral form launched
- New FY25 code went active
- ICC referrals are open
- All June referrals counting towards FY25 totals
