June 11, 2025, CCPAC Meeting Minutes – Theresa Collins, CCPAC Co-Chair

IDoA Staffing Update - Becky Dragoo, IDoA Deputy Director

<u>CCPAC Subcommittees – Becky Dragoo</u>

- Services subcommittee Met July 9, working on updating INH review tool. Setting up entrance and exit
 conferences during reviews.
- Bylaws subcommittee Ella Grays motioned to vote to approve the revised CCPAC Bylaws, Richard Juarez seconded the motion, motion passed with all present members voting yes.
- Policy subcommittee Home Care Aide of Choice policy has been released. Updates were made to the Training Tracking Portal policy. Changes went live August 1st, 2025.
- Training subcommittee Met in May and went over results from State of the Workforce Survey. Working with Rush University to launch the development of a core training curriculum for direct service workers across all waiver programs. Preparing for this years State of the Workforce Survey.

- Technology Subcommittee First meeting was held on July 17, 2025. Initial limited group voted to expand group size to include all that requested to be involved.
 - o Identified five goals for the subcommittee:
 - Connected systems and applications of the aging network where possible
 - Identify gaps within the systems currently in use
 - Identify where we can automate actions within the systems
 - Identify where to prioritize our actions to improve systems
 - Provide input to the Department's technology strategic plan
 - o To review CERA, TTP, Aging Cares, and eCCPIS

Fiscal/Budget Update - Theresa McKeon, IDoA

- Stated to continue submitting FY25 billing
- eCCPIS was opened August 13 for new billing for FY26
- Both FY25 and FY26 billings were to run through the end of August
- In-Home Rate increase to go into place January 1. 2026 or upon approval by Federal CMS

EVV/HHA/State Aggregator Update - Becky Dragoo, IDoA; Pam Winsel, HFS

- After delays, approval has been granted to include non-Medicaid population
- Pam Winsel from HFS expects to have additional information soon regarding updates for EVV/HHA

State of the Workforce Survey - Becky Dragoo, IDoA

- Survey to open September and run through November
- Testing to begin mid-August to verify emails

IDoA Conference October 15-16 - Call for Proposals - Liz Vogt, IDoA

- Call for Proposals opened, IDoA asking to hear from providers regarding innovation that will close on August 24th
- Accepted proposals will be contacted in mid-September

<u>Federal Updates – Becky Dragoo, IDoA</u>

- IDoA is monitoring the potential impact of changes at the Federal level that could impact home and communitybased services and the need for more frequent determinations, and the work requirements for the population age group of 60 to 64.
