#### June 12, 2024, CCPAC Meeting Minutes – Becky Dragoo, CCPAC Co-Chair

Sherry Barter-Hamlin presented a motion to approve the June 12<sup>th</sup> meeting minutes, Ella Grays seconded the motion. It was carried with no comments or objections.

#### Public Comments - Becky Dragoo, CCPAC Co-Chair

The invitation for public comments was opened. No public comments were made.

#### Multi Sector Plan on Aging Announcement – Mary Killough, IDoA Director

Multi Sector Plan on Aging created by Executive Order from the Governor's office, signed on August 13, 2024. Will consist of an interagency task force and an advisory council that will establish the blueprint/plan for the Department on Aging. Plan to be presented to the General Assembly next year.

## IDoA Staffing Update - Becky Dragoo, CCPAC Co-Chair; Division Managers

Liz Vogt has assumed the role as Chief of Staff for IDoA.

Mike Berkes has left IDoA.

Vahagn Chiflikyan has started as a Community Care Specialist with OCCS in the Chicago office.

Chelsey Peters leaving IDoA for another state agency 8/30/2024.

#### CCPAC Subcommittees - Becky Dragoo, CCPAC Co-Chair; Sandra Pastore; Liz Vogt

Policy subcommittee – Reviewed legislative cycle and process. Reviewed regulatory process. Reviewing draft rules to IL89.220.

Services subcommittee – First meeting conducted, determined clarification is needed on rules, polices and monitoring guidelines.

Bylaws subcommittee – Being set up to review and determine if changes are needed in the CCPAC Bylaws. Request for members presented. Enough interest was posed to setup, kick off meeting to take place in October.

Training subcommittee – Home Care Aide training survey was extended to allow more time for responses.

### HHAeXchange/EVV Update – Pam Winsel, HFS

Contract amendment being prepared to move forward with implementing the changes to EVV for IDoA.

## HFS 1115 Waiver Service Expansion update – Becky Dragoo; Liz Vogt; Jennifer Hebel

1115 waiver service expansion will expand support around the social determinants of health, nutrition, and case management. HFS will be addressing three components first: medical respite, individuals exiting carceral settings, and nutrition/housing support.

#### LRI policy update – Liz Vogt

Based off feedback from CCUs and In-home providers, changes were made to the LRI policy. The policy establishes a new term – Home Care Aide of Choice, which includes the following: legally responsible individuals, family home care aides, and legal guardians. Preferred home care aides were removed from this grouping.

#### Fiscal/Budget Update - Sarah Harris, IDoA CFO

Invoicing for FY25 is being released. FY24 payments were being sent to the Comptrollers office. Some delay was being seen from the Comptrollers office due to the end of the fiscal year and seeing a significant increase in workflow.

Budget to include a Rate increase effective January 1, 2025.

## FY24 billing reminder/FY25 billing update - Sarah Harris, IDoA CFO

Reminder to submit billing for FY24 through normal process and to not submit through Court of Claims.

#### IATP – Illinois Care Connections – Jennifer Hebel, IDoA Special Research Assistant
