

## CHILD and ADULT CARE FOOD PROGRAM PUBLIC MEDIA RELEASE for PRICING PROGRAMS

The Illinois Department on Aging announces the below listed organizations as approved to participate in the USDA's Child and Adult Care Food Program (CACFP) for the current Federal Fiscal Year 2024, October 1, 2023 through September 30, 2024. The CACFP Program, administered by the U.S. Department of Agriculture and the Illinois Department on Aging, gives financial assistance to the Adult Day Service organizations. The meal services and snacks served to enrolled participants meet standards established by the U.S. Department of Agriculture under the adult meal pattern.

Listed below are the USDA Income Eligibility Guidelines which are effective July 1, 2023 through June 30, 2024. The amount of meal/snack service reimbursement received by an organization is based on the number of enrolled participants whose family income is at or below:
