- 2. Presentation Dana Kelly, Illinois Poverty Commission: Poverty Elimination Overview. Dana presented regarding the Poverty Commission's task of creating a strategic plan for poverty elimination, the goals of the plan became statutes and will be completed over a 15-year period. The goals include 1) reducing deep poverty in the State by 50% by 2026, 2) Eliminate child poverty in the State by 2031, and 3) Eliminate all poverty in the State by 2036. The goal of the Commission is to mine and uphold the work other are doing toward these goals to strengthen the impact. The Commission also has 5 Strategic Pillars to continue and support the work towards the goals. Along with this the Commission has Committees stablished for each of the pillars.
