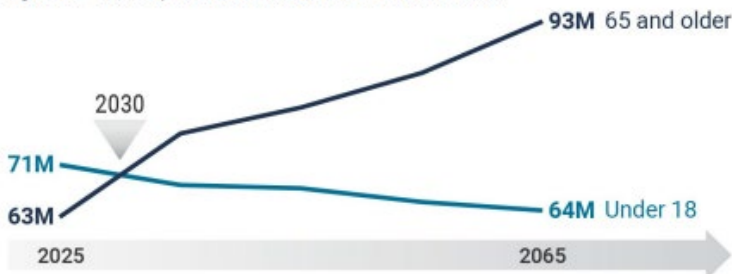

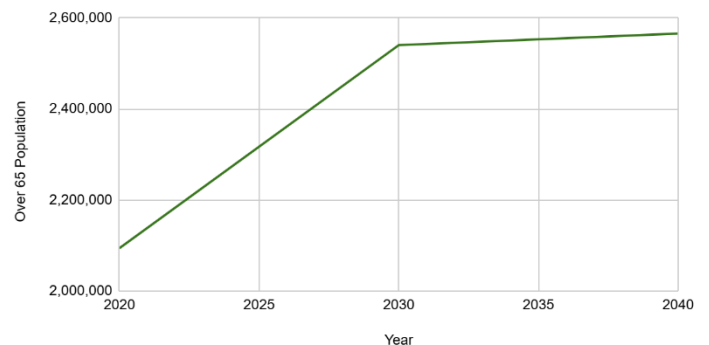
Historic Population Shift
