# Illinois Long-Term Care Council Annual Report FY2024

#### The Authority and Purpose of the Illinois Long Term Care Council

The Illinois Long Term Care Council (Council) was created in August 2003 by Public Act 93-0498, which added Section 4.04a of the Illinois Act on the Aging (Act) (20 ILCS 105/4.04a).

The purpose of the Council is to ensure high quality of care for persons aged 60 or older who need long-term care in the continuum of care – from home care to nursing home care. The Council provides a forum for making recommendations on systemic issues affecting the continuum of long-term care, and the efficacy of the State Long Term Care Ombudsman Program.

The Council makes recommendations concerning persons who need services in the continuum of long-term care. This includes persons living in facilities licensed or regulated under the:

- (1) Nursing Home Care Act: Skilled Nursing and Intermediate Care Facilities Code, Intermediate Care for Persons with Developmental Disabilities Code, Sheltered Care Facilities Code, and Illinois Veterans Homes Code
- (2) Assisted Living and Shared Housing Establishment Code
- (3) Community services including Supportive Living Facilities, regulated under the Illinois Department of Health Care and Family Services through a federal waiver (89 Ill. Adm. Code Part 146), Adult Day Care and any other type of long-term care provided in a home or other environment

#### **Council Mandates**

- Mandate I. Make recommendations and comment on issues pertaining to long-term care and the State Long-Term Care Ombudsman Program to the Illinois Department on Aging (Department).
- Mandate II. Advise the Department of Public Health and the Department on Aging matters pertaining to the quality of life and quality of care in the continuum of long-term care.
- Mandate III. Evaluate, comment on reports regarding, and make recommendations on the quality of life and quality of care in long-term care facilities and on the duties and responsibilities of the State Long-Term Care Ombudsman Program.

Mandate IV. Provide an opportunity for public input at each scheduled meeting.

#### Legislative Updates from the Office of the Long-Term Care Ombudsman

Listed below are the legislative initiatives proposed by the Long-Term Care Ombudsman Program which were passed by both chambers during the 103<sup>rd</sup> General Assembly.

SB2715 modifies IL Act on the Aging to clarify release of ombudsman resident records is allowed under limited circumstances.

HB5095 modifies the Nursing Home Care Act clarifying that a nursing home with a Distinct Part must provide a minimum of 5 days notification that the resident's Medicare coverage will likely end in 5 days.

HB4427 adds resident representation to the Assisted Living and Shared Housing Board.

SB2957 modifies the IL Act on the Aging to include language clarifying ombudsmen have access to facility incident reports with appropriate consent and allows for consent in means other than writing.

An additional piece of legislation that would strengthen rights related to discharges in the Nursing Home Care Act and the Assisted Living and Shared Housing Establishment Act is HB5151. The final amendments were on concurrence when the House adjourned for the summer.

#### **New Member Recruitment**

Over the last several years, the Council lost members due to resignations, term limitations, and the lingering impact of the COVID-19 pandemic. Rebuilding the membership continues to be an ongoing focus. The Department will continue to work on securing new members to ensure the Council is comprised of the diverse background envisioned by the Act.

#### 2024 Council Goals On-Going

The Council discussed several goals for the year and a survey was developed to rank the goals in order of priority. These goals are listed below:

1.Pursue required training for CNA's focusing on compassion and empathy towards long-term care residents and the aging population

- 2. Advocate for person-centered care in long-term care facilities
- 3. Discuss and propose legislative solutions from problems identified in long-term care facilities
