Department on Aging

Jose Jimenez gave the following updates:

- Federal CMS waiver renewed
 - Will provide summary of changes and new timelines
 - Deadlines to follow through on
 - Critical incident reporting
 - Person Centered planning training next Thursday for CCUs
- Budget
 - Stop gap funding going to certain services
 - Consent decrees
 - Made whole on FY16 payments; working on interest payments from FY16
- Adult Protection and Advocacy Conference October 25-27 in Zion
 - Put on by Ombudsman and Adult Protective Services
 - Training will be provided to Ombudsman; some all-inclusive training will be provided
 - · Ombudsman working with veterans personal safety session
 - · Disability Dementia
 - Bill Benson speaking to new rules
 - Crossover APS and criminal abuse training
 - Anthony Vaughn veterans' issues
- State Plan on Aging
 - for federal funding from the Administration for Community Living
 - · 3 presentations

Chairman Iden inquired if the December conference was cancelled. Jose stated that because of the budget impasse and no funding provided in the stop-gap bill, that the conference would be cancelled this year.

- ...Jose Alzheimer's
 - will allow more soon
 - federal funding for more training

Department of Healthcare and Family Services

Janene Brickey gave the following updates:

- Delay
- Long Term Care prov. billing process moving forward
 - Beginning October 1st, providers bill state; webpage dedicated to the process
- Medicaid providers cloud based system; Illinois Medicaid cloud tech reenrolled tens of thousands of providers
- Working on waiver renewal for next year public comment by end of year
- Supportive Living Program opened -accepting applications for Dementia care through March; other states looking at Illinois as a model
- No 1115 Waiver update at this time
 - · different from old 1115 waiver; addition of behavioral health

Action Item: Janene will prepare update for next Council meeting.

Illinois State Police

Phil Miller gave the following updates:

- Have two new code investigators; one in Chicago and one in Collinsville
- Downstate problem with drug diversion in long term care facilities; might see in press
 - Medicaid mission provider, not recipient recipient is under HFS/OEIG
 - Hotline number

Jamie asked if there was anything the Ombudsmen could do. Phil replied – local jurisdiction also. Darlene – refer to Department of Public Health as a drug diversion complaint

- make sure resident is getting what they need
- facility staff mandated to report to the Department of Public Health
- Darlene Illinois State Police send email when problem occurs; some facilities don't report properly Phil will add to notification

Wayne Smallwood asked what the volume and frequency of the problem was. Phil replied that a couple per week was the average reported.

Department of Veterans' Affairs

Gwen Deihl gave the following updates:

- Construction fund for Chicago veterans' home restored
 - · lining up contractors
 - small, house model
 - · 4250 N. Oak Park
 - green house
 - · 200 bed
 - · construction should be completed in spring or summer of 2018

Wayne Smallwood asked how many veterans' long term care facilities existed; Gwen stated that there would be five with the new Chicago facility, with 950 beds total. She added the further breakdown of veterans' long term care facilities in the state:

- 15 bed homeless facility
- 53 bed facility in Quincy for Dementia care
- 40 bed facility in >>>> for Dementia care
- 43 bed facility in >>>> for Dementia care

Department of Public Health

Darlene Harney gave the following updates:

- CMS sent out final rule 713 pages, effective November 2016
 - working through
 - · updates requirements for long term care facilities
 - more flexibility to providers
 - enhance the quality of care and clinical outcomes
 - · waiting on interpretive guidance
 - · changes to tags, surveys
 - on CMS website

Janene Brickey – a lot like rule being used for waiver

Jamie Freschi asked about the timeframes for implementation; Darlene Harney stated that the new rule is effective November 28, 2016. Emergency preparedness phased in by November of 2017.

Wayne Smallwood – need approval from CMS on implementation? Darlene stated that they are waiting on interpretive guidelines and would take the lead from CMS. She added the following:

- · Changes/combinations of tags
- monthly calls with federal CMS
- · won't affect licensed only facilities, only those certified through federal CMS

Action Item: 1049 with state licenses – Darlene will provide breakdown of licensed/certified facilities and send to Jessica Blood for distribution to the Council.

University of Illinois at Springfield Gerontology

Carolyn Peck gave the following updates:

- Stop-gap funding recipients; disbursed as best as possible
- Enrollment is up at all three campuses
- Online and blended courses drawing large base

Ombudsman Program

Jamie Freschi gave the following updates:

- Introduced Chuck Miller
 - new to program 2 weeks
 - worked in Home and Community Based Services for 14 years ADS and in home care audits
- Finish designation process
- 2 new Ombudsman providers
 - PSA 6 West Central ADRC; regional Ombudsman Steven Maxwell
 - PSA 7 Area Agency on Aging for Lincoln Land; looking to hire more regional Ombudsmen
 - PSA 8 had no bids; Land of Lincoln Legal Assistance Foundation agreed to stay on for remainder of FY17
- New Regional Ombudsman Kate Flynn, PSA 2
- Federal Rule implemented July 1st
 - Change to Level 1 training; sharing changes as they go with current training
- Revising State Rule policies and procedures
- Working on Ombudsman website
 - · Consumer choice individuals will be able to look at facilities in specified areas

- · will have information/links to facilities
- · filtered search
- · all facilities required to fill out survey; some questions mandatory, some voluntary
- no date yet on completion
- Ombudsman portal updated forms, etc.
- Home Care Ombudsman Program
 - Three year demonstration grant ending
 - · Weren't getting cases
 - Effective January 1st, will be managed at state level
 - Working with Department on Aging, Administration for Community Living and the Department of Healthcare and Family Services
 - Will hire five new staff; mostly in Chicago area
 - Monitoring and case work through the state via the Senior Helpline
 - Transitioning now through December 31st

Ann Ford asked if the program was restricted to MMAI and waivers; Jamie responded yes. Ann then inquired if there was any plan to expand the program; Jamie stated that she hoped it would expand in the future, but that would depend on funding and staffing.

Marsha Johnson stated that not seeing in person would be a detriment to the setup of the program because the Ombudsman might not be able to see the full picture of things going on; don't know who is with them and they may not speak freely.

Jose – pausing; bringing in house for more control – get message out about program Restructuring; better system moving forward – waiting on two year grant for Home Care Ombudsman program – another demo

Chairman Iden stated that Council members should send any ideas for speakers or agenda items to Department on Aging staff before the next meeting.
