## Updates on priority areas

## **Department on Aging:**

- Sandra Alexander reported that the 2012 OASAC report was filed December 2011 and hardcopies will be available at the Full meeting and also available on Aging website.
- A report has been filed with the House and Senate appropriations committee for ESP database as an inventory of services.

## Department of Healthcare and Family Services: Kelly Cunningham

• Kelly is working with sister agencies on the long term care rebalancing to identify system changes to make application successful.

# Department of Public Health: Bill Bell

- Bill Bell reported that IDPH is working on compliance issues in Senate Bill 326.
- IDPH is also working on the agreement with pharmaceutical companies to run data on the medication project.

#### Department of Human Services: Rob Kilbury

• DHS is participating on workgroups set up by the Governor's office to address the reduction of inappropriate referrals/placement of individuals in nursing homes.

#### Housing & Development Authority: Sam Mordka

- Sam indicated that IDHA is improving referral networks
- IDHA is developing a train-the-training program for the caseworker portal on ILHousingSearch.org
- Lake in the Hills Development opening up soon. Priority will be given to persons transitioning out of nursing homes; 55+ rental subsidy, but still must go thru referral process. This may be an opportunity for MFP program for individuals transitioning out of long term care.

#### **Department of Insurance: Sandy Leith**

• Working with HFS in creating rules for the long term care partnership program which is ready to go to JCAR.
