

### OASAC Personal Assistant (PA) Workgroup

#### ***Background and Purpose of the Personal Assistant (PA) Workgroup***

At the July meeting of the OASAC Executive Committee, members requested that a workgroup be formed to review the issues around a Personal Assistant (PA) self directed home and community based service, and to make recommendations to the State with regard to this service as it pertains to the 1115 waiver proposal recently submitted to CMS. Potential areas for discussion include, but are not limited to the following:

- Research national practices for the PA self – directed model.
- Outline the implications with regard to implementation of the PA/self directed model from the perspective of the aging and disability network (e.g., consumers, provider agencies, workers, etc...). Include topics such as grievance process; training; mitigating waste, fraud and abuse; and assessing capacity for the service for consumers with declining functioning.
- Make recommendations to IDoA, DHS and HFS for consideration of a PA/self directed model program in Illinois.
