

 - 613,589 older adults and 248,468 caregivers reside in suburban Cook County
 - 15% are limited English Speaking
- Our mission is to innovate, partner and advocate to improve systems and services to strengthen communities so people thrive as they age.





Program Design


- AgeOptions hosts online informational events featuring speakers on various aging and LGBT+ topics of interest followed by Q&A. We then provide our funded partners with event recordings and discussion guides so they can facilitate their own follow-up events.
- Cafe partners are asked to meet once a month, providing a safe and welcoming space for older LGBT+ adults and caregivers to congregate and learn more about their local resources in whatever format works best for their participants (in-person, hybrid, virtual).

Intergenerational Events

- To combat social isolation experienced by many in our community (made worse by the pandemic)
- To preserve the rich and complicated histories of sexual and gender minorities
- To teach and learn from one another (not just one-way conversation)
- To draw on the joy and strengths of our community members of all ages



Community Agreements

We will practice mutual respect. This includes:

- Using each person's name and pronouns
 - Example: "My name is Nina. I use she/her pronouns. What pronouns should I use for you?"
- Understanding that others may use different language or terms to describe themselves
 - Example: Some folks may identify as queer, while others may find that term offensive each for their own valid reasons. We must respect all identities even if we do not agree with a term.
- Being mindful of boundaries and personal space when interacting
 - Example: Not everyone is comfortable with physical touch like shaking hands or hugging, so always ask first.

We will value impact over intent. This means:

- The consequences of our words and actions, and how they are perceived by others, are more important than our original intentions, even if those intentions were good.
 - Example: If I step on your toe, it was not intentional, but I still need to apologize for the hurt it caused you and avoid doing it again.

We will make space for all voices. This means:

• We are coming together intentionally across generations. We all bring different knowledge and lived experiences to the table. We all have something to contribute and are open to learning from one another.












How do we factor into mainstream Long-term Care?

How to Find an Affirming Community

Look for:



Communities that have signed up for the Long-Term Care Equality Index (LEI), which sets the first national standards for inclusive LGBT+ policies and practices in senior housing and residential LTC

Communities that have received a <u>SAGECare</u> certification means that a certain percentage of staff have completed training specific to LGBT older adults. Bronze→Platinum



All Rights Reserved. As an LGBT older adult or a caregiver, you and your loved one might be considering home care or long-term care services. However, you might be concerned about finding services and programs that are LGBT affirming. Inviting someone into your home or revealing personal information can be intimidating at any time, and you may be feeling particularly vulnerable at this point in time. It is important to find service providers who understand LGBT issues and can be trusted to provide you with competent, respectful care. Here are ten helpful tips on finding an LGBT-affirming service provider:

- The best references come from the people you already know and trust. Ask friends with similar circumstances who they have worked with, and whether they felt respected and comfortable.
- Contact your local SAGE Affiliate or LGBT aging provider, LGBT Community Center, PFLAG chapter or other LGBT organizations and ask for referrals to providers they have worked with in their networks.
- Look to see if there are service providers that advertise in your local LGBT newspapers and magazines (either print or online) or have signed up as sponsors, members, etc. with local LGBT groups.
- Reach out to your local HIV/AIDS service providers, who often have close connections to LGBT-affirming home care agencies and other services.

Questions to Determine a Facility's LGBT+ Friendliness

- What is your non-discrimination policy?
- What percentage of residents are LGBT+?
- Have staff and management received LGBT+ specific certification or cultural competency training?
- Does your site participate in the Long-term Care Quality Index?
- Do you have a LGBT+ affinity group?
- What enrichment activities do you offer?
- What are your policies on cohabitation?
- Can I speak with current residents?
- What are their policies on bullying and harassment between residents?

Visual, Verbal, Physical cues

Prominent displays of nondiscriminatory policies in the lobby or on the website Inclusive language on forms (such as non-binary gender options or acknowledgment of families of choice)

- Ask trusted providers or organizations who they would recommend


