# Gov. Pritzker Signs Legislation Establishing Grandparents Raising Grandchildren Pilot Program



Governor JB Pritzker recently signed House Bill 780 to establish and administer a Grandparents Raising Grandchildren Pilot Program in Will County beginning January 1, 2024, through January 1, 2027. IDoA worked in close coordination with Leader Natalie Manley to establish this legislation that amends the Illinois Act on Aging. It will require an intake coordinator for Will County

to be responsible for connecting grandparents raising grandchildren to relevant resources and services provided by state agencies.

This pilot program will have multigenerational benefits, advancing the reach and impact of Illinois' existing Grandparents Raising Grandchildren Program that works to locate, assist and promote awareness of older caregivers who are currently raising their family's children.

# Get Ready to Renew Your Medicaid

# **GOT MEDICAID**?

Medicaid customers have not had to renew their Medicaid coverage since the COVID-19 pandemic began. Medicaid pays for healthcare, like doctor visits, prescription medicine, and urgent emergency services.

Now Illinois is starting renewals again to see if people are still eligible. Everybody's renewal date is different, so it is critical that you get ready to renew.

Don't risk losing your Medicaid! Here is what you need to do:

Click Manage My Case at abe.illinois.gov to:

- Verify your mailing address under "contact us."
- Find your due date (also called redetermination date) in your "benefit details".

Watch your mail and complete your renewal right away.

If you are no longer eligible for Medicaid, connect to coverage at work or through the official Affordable Care Act marketplace for Illinois, <u>GetCoveredIllinois.gov</u>.
